The sport of curling presents some unique challenges to players. Stepping onto and walking on the ice surface, delivering a rock from the hack or from a standing position, sweeping and avoiding contact with rocks in motion and positioned in the house, all require balance, anticipation, reflex motion, flexibility, strength, and agility.

For their own safety, and for the safety of others on the ice, **players must be confident that they are physically and mentally able to address these challenges.**
